Board of Trustees' Responsibilities and Approval

The **Board of Trustees (BOT)** of **NDES FOUNDATION** oversees the proper and assiduous management of the foundation. They are charged with the responsibility of selecting beneficiaries and approving the annual budget of the foundation. It is their responsibility to ensure that the financial statements satisfy the financial reporting standards as to form and content and present fairly the statement of income and expenditure, of the foundation as of November 30th, 2019. The financial statements are based upon appropriate accounting policies consistently applied throughout the foundation and supported by reasonable and prudent judgements and estimates. The BOT acknowledges that they are ultimately responsible for the system of internal financial control established by the foundation and place considerable importance on maintaining a strong control environment. To enable the management to meet these responsibilities, the BOT sets standards for internal control aimed at reducing the risk of error or loss in a cost effective manner. The standards include the proper delegation of responsibilities within a clearly defined framework, effective accounting procedures and adequate segregation of duties to ensure an acceptable level of risk. These controls are monitored throughout the foundation's activities are conducted in a manner that in all reasonable circumstances is above reproach.

The focus of risk management in the foundation is on identifying, assessing, managing and monitoring all known forms of risk across the foundation. While operating risk cannot be fully eliminated, the foundation endeavours to minimise it by ensuring that appropriate infrastructure, controls, systems and ethical behaviour are applied and managed within predetermined procedures and constraints.

The **BOT** is of the opinion, based on the information and explanations given by the Executive Burea that the system of internal control provides reasonable assurance that the financial records may be relied upon for the preparation of the financial statements. However, any system of internal financial control can provide only reasonable, and not absolute, assurance against material misstatement or loss. The going-concern basis has been adopted in preparing the financial statements. Based on forecasts and available cash resources the **BOT** has no reason to believe that the foundation will not be a going concern in the foreseeable future. The financial statements support the viability of the foundation.

Executive Bureau's Report

The Executive Bureau is charged with the responsibility of seeing the day to day operations of the foundation. This report is an accurate brief of the foundation activities as at 30 November 2019.

1. Review of activities:

The principal activity of the foundation is in the provision of health and education assistance to the underprivileged. We consider underprivileged persons to be those disadvantaged socially, economically and physically especially orphans and persons living with disabilities (PLWD). Within the period starting from July to November 2019, the foundation has carried out the following charity activities.

a. Outreach to the elderly in Mbengwi.

On the 11th of August 2019 the foundation undertook its maiden outreach activity by visiting some elderly persons of the Mendere Dance Group in Mbengwi, Momo Division of the North West Region. Food items and materials were handed as gifts to the elders to supplement their diet

b. Scholarship Award and Educational materials to 03 Orphanages.

This activity was carried out on the 29th of August 2019 in Molyko Buea. A total of 28 kids from three orphanages- Teleola Martha Foundation, St. Glory Orphanage and Mountains Kids Orphanage- were handed complete educational materials for the academic year 2019/2020. In addition, three of the most brilliant orphans were handed cash scholarship awards to pay their tuition fees for the academic year. Food stuffs and basic necessities were equally handed to each of the orphanages.

c. Financial Assistance to 29 Hemodialysis Patients

Aware of the difficulties kidney failure patients face, the foundation offered financial assistance to cover the cost of dialysis for 17 patients for a month (04 sessions each) and the purchase of EPAIO injections for 12 others. This was done on the 29th of September, 2019 at the premises of the Hemodialysis center of the Regional Hospital Buea (RHB). The cost of a dialysis session in Cameroon is fixed at 5000XAF.

d. Financial Assistance to 15 Hemodialysis Patients

On the 08th of November 2019, 15 more patients of the center benefited from another month of free dialysis. Medical crocs were equally handed over to the management of the center. The foundation works with the technical staff of the center to impairtially identify the most needy and economically challenged patients to benefit from the financial assistance.

e. Inter-orphanage Educative Outdoor Retreat.

An interactive and educative outdoor retreat was organized at the premises of the Alliance Francaise Camerounaise on the 16th of November 2019 for 04 orphanages within the Buea Municipality. This saw the bringing together of over 60 orphans from 04 participating orphanages which included; Teleola Martha Foundation, St. Glory Orphanage, Mountains Kids Orphanage and Ayah Foundation. Through quiz and dancing competitions, the kids were able to interact with their peers and learn in a playful environment. Individuals of high social standings were invited to offer psycho-social support and livelihood skills to the kids as they shared their dreams and aspirations. Basic necessities that included menstrual pads, bed sheets and bathing soap were donated to the orphanges.





2. Partnerships.

The **NDES FOUNDATION** strongly believes in the power of synergy and actively seeks to establish partnerships with donor and beneficiary organisations. We have signed a Memorandum of Understanding (MOU), with the Rehabilitation Institute for the Blind (RIB) Buea and are looking to carry out sustainable projects with the institute that will improve the economic, vocational, heath, WASH and physical status of the blind trainees of the institute and to reintergrate them into the society. A prospective MOU is underway with the Regional Hospital Buea to assist underprivileged patients of the hospital.

3. Going concern

The financial statements have been prepared on the basis of accounting policies applicable to a going concern. This basis presumes that funds will be available to finance future operations and that the realisation of assets and settlement of liabilities, contingent obligations and commitments will occur in the ordinary course of business. The charity activities, operational activities and the income and expenditure statement of the foundation are fully described in this report and in the attached financial statements.

ACCOUNTING POLICIES

1. General information

The principal activity of **NDES FOUNDATION** is in the provision of health care and education assistance to the underprivileged. This entails offering material and financial assistance to better the health care and WASH (Water, Sanitation and Hygiene) status of the underprivileged as well as highly economically challenged persons suffering from chronic diseases. We equally offer material and scholarship awards to improve access to quality education by underprivileged pupils and students especially to orphans and persons living with disabilities (PLWD).

2. Summary of significant accounting policies

These financial statements have been prepared in accordance with the OHADA Financial Reporting Standards. The principal accounting policies applied in the preparation of these financial statements are set out below.

These financial statements have been prepared under the historical cost convention and are presented in Francs CFA (XAF).

2.1. Revenue recognition

Revenue comprises the fair value of the funds received or receivable from donors and members in the ordinary course of the foundation's activities.

The foundation recognises revenue when the amount of revenue can be reliably measured; it is probable that future economic benefits will flow to the entity; and specific criteria have been met for each of the foundation's activities, as described below:

2.2. Income taxes

The foundation has been approved as a public benefit foundation and is exempted from company taxation. She is however liable to the personal income tax deducted from workers salaries at the end of each month.

The public benefit foundation has been approved in accordance with the Cameroon general tax code and donations to the foundation will be tax deductible in the hands of the donors in terms of and subject to the limitations prescribed in the relevant sections of the Cameroon tax code. 2.3. Cash and cash equivalents

Cash and cash equivalents includes cash in hand, cash at bank and other donations made by donors to the foundation's online fund raising accounts.
